23 The above entitled cause having been referred to the Division of
24 Water Rights (now Division of Water Resources) of the Department of Public
25 Works of the State of California, as referee, by an order of this Court,
26 entered on August 15, 1926, and made under authority of law as conferred by
27 Section 24 of the Water Commission Act of the State of California, Statutes
28 of 1913, Chapter 586, as amended; said referee having made its investigation;
29 thereafter all of the parties except R. P. Cunningham and Estate of Jay
30 Yordy, having entered into a written stipulation and agreement; said
31 stipulation providing that this Court might enter its decree in accordance
with the provisions of said stipulation; said stipulation further providing

1 that findings of fact and conclusions of law be waived; said Division, as
2 referee, having submitted its report to the Court on March 15, 1930, and
3 having submitted a supplemental report to the Court on August 1, 1932;
4 action having been dismissed as against defendant R. P. Cunningham by an
5 order of the Court, dated June 20, 1935; Elizabeth R. Thomas, Russell E.
6 Love, M. C. Lysinger, Vivian Fugitt, J. C. Burdick, D. W. Ide and Addielee
7 Ide, Cora Rice, Esther L. Ensley, and Vernon Worley and Alvin Worley having
8 been substituted for parties defendant respectively in place of defendants
9 Marcus E. Thomas, John F. Krehbiel, T. J. Ray, Mt. Shasta Coal Company, S.
10 M. Dunn and Orval Lee Dunn and Mary Eleanor Dunn, James W. Ballard, John
11 Larkin, Administrator of the Estate of John B. Carswell, deceased. E. D.
12 Herrick and Edith E. Herrick, and G. U. Worley; all of said parties so
13 substituted, except Vivian Fugitt, having ratified, confirmed and adopted
14 the terms and provisions of said stipulation and agreement; said Vivian
15 Fugitt having ratified, confirmed and adopted the terms and provisions of
16 said stipulation and agreement with the proviso that said terms and pro-
17 visions of said stipulation and agreement shall apply to said Mt. Shasta
18 Coal Company and to said Vivian Fugitt as substituted in lieu and instead
19 of said Mt. Shasta Coal Company, as same are corrected, amended and modified
20 in said supplemental report of referee submitted to the Court on August 1,
21 1932; the above entitled cause having been set for hearing before this Court
22 on October 4, 1937; said cause having come on regularly for trial before the
23 above entitled Court, sitting without a jury, on said October 4, 1937; de-
24 fendant Leslie A. Yordy, administrator of the Estate of Jay Yordy, deceased,
25 having been duly and regularly notified of the hearing and trial of said
26 cause before this Court, and said defendant having failed to appear at said
27 hearing and trial, and having thereby waived findings of fact and conclusions
28 of law; the evidence presented and filed by the referee and included within
29 its report and supplemental report being the only evidence offered or
30 introduced at said trial; the evidence being closed; said cause being sub-
31 mitted to the Court for its determination and decision; the Court being fully

1 advised in the premises; and it further appearing as follows:

2 (1) That E. A. Sheridan, A. O. Sheridan, and Margaret Sheridan own
3 interests, jointly, with defendant John Simeon Sheridan in that portion of
4 the Sheridan property, known as the M. A. Sheridan Ranch involved in this
5 action.

6 (2) That Dave Covey and David E. Covey are one and the same person.

7 (3) That Mary Jane Reineke, Annie Dora Drifer, Wallace Emsley
8 Reineke, Henry Clay Reineke, Irene Reineke, Margaret Eliza Reineke, John
9 Luke Reineke, and Blaine Reineke own interests, jointly, with defendant
10 Charles G. Reineke in his property involved in said action.

11 (4) That J. R. Hunt, Jr., John W. Maxwell, Mary Jane Reineke, Annie
12 Dora Drifer, Wallace Emsley Reineke, Henry Clay Reineke, Irene Reineke,
13 Margaret Eliza Reineke, John Luke Reineke, Blaine Reineke, E. A. Sheridan,
14 A. O. Sheridan, Margaret Sheridan, and E. G. Weigart have been served with
15 summons and complaint in this action as members of the Doe Family and each
16 and all of said persons have entered into said stipulation for judgment and
17 that the pleadings on file in this action are hereby amended so that the
18 aforesaid parties shall appear respectively in the place and stead of First
19 Doe to Fourteenth Doe inclusive.

20 (5) That the true name of defendant sued herein as Isaac E. Ray is
21 A. F. Ray and said defendant has appeared in his true name; that by transfers,
22 subsequent to the time of filing of complaint herein, the property of A. F.
23 Ray here involved, was transferred to California Lands, Inc., and from
24 California Lands, Inc., to Robert T. Wood, the present owner.

25 (6) That from various documents and records on file herein, it
26 appears that the following persons or parties have agreed to pay their ap-
27 portioned share of the expenses of referee herein (transferees or successors
28 to ownership of the same real property being grouped together for convenience
29 of reference):

20 NOW THEREFORE IT IS HEREBY ORDERED, ADJUDGED AND DECREED AS FOLLOWS,

21 TO WIT:

22 (1st) There is in said Shasta County a natural stream of water

23 known as and called "Clover Creek", which said stream arises on the southerly

24 slope of Snow Mountain in said Shasta County, State of California, and flows

25 thence in a general southwesterly direction to its confluence with Old Cow

26 Creek below Millville between well defined banks in a well defined channel

27 to, upon, and across certain of the lands of certain of the parties to this

28 action, which lands are hereinafter described in Schedule 1 hereunto annexed

29 and made a part hereof.

30 (2nd) The party plaintiff and parties defendant in the above entitled

31 action are the owners of the lands described in their respective pleadings;

1 the allotments of water from said Clover Creek and its tributaries as here-
2 inafter set forth are for use upon the acreages hereinafter described; the
3 respective parties are the owners of the acreages hereinafter set forth
4 under their respective names; and said lands are depicted on two maps, one
5 of said maps being referred to herein as the "Division of Water Rights Map,"
6 which map was prepared by the Division of Water Rights (now Division of Water
7 Resources) of the Department of Public Works of the State of California from
8 its surveys made in 1927, and is entitled, "Clover Creek Showing Diversion
9 Systems and Irrigated Lands," and is dated 1927, and the other of said maps
10 being prepared by said Division of Water Resources from a re-survey in 1932
11 of the lands of defendants Harvey Austin Klinger, and Ben Hall and Vivian
12 Fugitt, which maps have been filed in the above entitled cause.

13 (3rd) The party plaintiff and the parties defendant are the owners
14 of, or interested in, the ditches, conduits and other means of diversion de-
15 scribed in their respective pleadings, and as depicted on said Division of
16 Water Rights Map and are entitled to divert water, as hereinafter set forth,
17 through said means of diversion at the points of diversion depicted on said
18 map, and as hereinafter described in Schedule 3 hereunto annexed and made a
19 part hereof.

20 (4th) The several parties to this action are the owners of the
21 natural flow of Clover Creek and its tributaries, and are the owners of
22 rights in and to the use thereof, during the period from May first to
23 October thirty-first, both dates inclusive, of each and every year for
24 domestic, stock watering and irrigation purposes upon their respective
25 lands as described under their respective names in Schedule 1 hereof, in
26 accordance with the quantities of water allotted and to be diverted by means
27 of the ditches named as set forth in Schedule 2, hereunto annexed and made
28 a part hereof; and said rights set forth in said Schedule 2 are equal in
29 priority and correlative in right and at all times when the net available
30 water supply of said Clover Creek and its tributaries is inadequate to
31 supply the combined allotments set forth in said Schedule 2, then during the

1 continuance of such shortage, the owners of said allotments shall prorate
2 said net available water supply in accordance with their respective maximum
3 allotments set forth in said Schedule 2; provided, however, that no party
4 herein allotted water shall divert from said Clover Creek and its tributaries
5 at any time, a quantity of water in excess of that reasonably necessary for
6 his requirements and being put to beneficial use by said party.

7 (5th) Subject to all of the foregoing rights, James B. Anderson
8 shall at all times be entitled to divert from the natural flow of Clover
9 Creek, through the Mill Ditch as described in Schedule 3 hereof, ten (10)
10 cubic feet per second, or as much thereof as he directly applies to beneficial
11 use for power purposes at the Anderson Saw Mill situated within the NW¹ SW¹
12 of Section 25, T. 33 N., R. 1 W., M.D.B. & M.; provided that if at any time
13 during the season of irrigation the net available water supply of Clover
14 Creek and its tributaries is inadequate to supply the combined maximum
15 allotments therefrom as provided in the preceding paragraph (4th), or as
16 much thereof as is required for beneficial use by the parties and for the
17 purposes therein named, then during the continuance of such shortage during
18 the season of irrigation said James B. Anderson shall not divert any water
19 for such power purposes; and provided further that all water diverted under
20 the right provided in this paragraph, with the exception of that reasonably
21 lost in transportation, shall be discharged at a point immediately below said
22 saw mill into Anderson Swale leading in a westerly direction therefrom.

23 (6th) Subject to all of the foregoing rights, the parties herein-
24 after named in this paragraph are entitled to divert, during the period from
25 May first to October thirty-first of each and every year, the entire flow in
26 Anderson Swale, which receives the waste and return flow from the Anderson
27 Saw Mill, the J. B. Anderson irrigated lands, and the central and southern
28 portions of the Fred Wheelock irrigated lands, or as much of said flow as
29 said parties directly apply to beneficial use for domestic, stock watering
30 and irrigation purposes upon their respective lands as described in Schedule
31 1 hereof, in the respective proportions and through the respective laterals

1 of the Mill Ditch System as hereinafter provided in this paragraph, to wit:

11 (7th) At all times when the amount of water received by William
12 Stacher from Anderson Swale through the South Lateral of the Mill Ditch
13 System under paragraph 6 hereof, is less than 0.60 cubic foot per second,
14 measured at the south boundary of the Sheridan lands as described in
15 Schedule 1 hereof, then said William Stacher shall be entitled to divert from
16 the natural flow of Wild Cat Creek, through the Wild Cat Ditch, a quantity of
17 supplemental water sufficient to cover such difference; said diversion from
18 said Wild Cat Creek to be limited to the amount that he directly applies to
19 beneficial use for domestic, stock watering, and irrigation purposes upon his
20 lands as described in said Schedule 1.

21 (8th) Nothing herein contained shall be construed as limiting or
22 restricting the right of any riparian owner on said Clover Creek or its
23 tributaries to divert and apply to beneficial use on any riparian lands other
24 than those described in Schedule 1 hereof, any waters of Clover Creek or its
25 tributaries over and above those waters hereinabove allotted.

26 (9th) Nothing herein contained shall be construed as a waiver of
27 the right of any party hereto to appropriate, upon application and proceedings
28 before the Division of Water Resources of the Department of Public Works of
29 the State of California as now or hereafter constituted, or its successor in
30 the administration of the Water Commission Act, and apply to beneficial use
31 on any lands other than those described in Schedule 1 hereof, any waters of

1 Clover Creek or its tributaries over and above those waters hereinabove
2 allotted, nor shall anything herein contained be construed as a waiver of
3 the right of any party hereto to protest or take other appropriate action
4 against the issuance of a permit for the appropriation of water from Clover
5 Creek or its tributaries, or toward the prevention of such an appropriation.

6 (10th) Subject to the provisions of paragraphs (8th) and (9th)
7 hereof, whenever there is a surplus of water in Clover Creek and its tribu-
8 taries over and above the flow necessary to supply all of the rights here-
9 inabove provided, then such surplus water may be apportioned among the
10 parties hereto for use for domestic and stock watering purposes and for the
11 irrigation of their respective lands as described in Schedule 1 hereof, in
12 the ratios that their respective maximum allotments, as set forth in Schedule
13 2 hereof, bear to the total of their maximum allotments provided in said
14 Schedule 2; provided, however, that the amounts of surplus water so diverted
15 shall be limited to the amounts of water beneficially used for said purposes.

16 (11th) The allotments herein made may be transferred and used upon
17 other lands than those designated herein, provided that such substituted lands
18 have the same ownership and lie upon or near to the streams, respectively,
19 from which diversions are made and so that any waste or drainage shall flow
20 directly into said streams, respectively.

21 (12th) Nothing herein contained shall be so construed or applied
22 as to prevent any riparian owner from using the waters of any stream upon his
23 riparian land for power purposes, provided such use shall not appreciably
24 diminish the natural flow of such stream, and provided, further, that the
25 return flow shall be above the diversion point of the next lower user.

26 (13th) The Division of Water Resources of the Department of Public
27 Works of the State of California, as now or hereafter constituted, or its
28 successor in the administration of the Water Commission Act, shall supervise
29 diversions from Clover Creek and its tributaries, through the agency of a
30 water master, whenever necessity for such water master service is found to
31 exist by said Division, and that the cost and expenses of such water master

1 service shall be borne by the parties hereto, said costs and expenses to be
2 apportioned among said parties in accordance with the method of apportioning
3 the costs of water distribution by water master provided in Section 37f of
4 the Water Commission Act of the State of California.

5 (14th) The owners of each ditch through which water is diverted from
6 Clover Creek and its tributaries as herein provided, shall install, under the
7 supervision of an engineer appointed by the Division of Water Resources, such
8 permanent diversion works, headgates and measuring devices in their respective
9 ditches as shall be required and approved by said Division; such installations
10 to be made prior to October 1, 1937, or such later date as may be ordered by
11 the above entitled court. The several ditch owners shall furnish all neces-
12 sary labor and material for the construction and installation of said diver-
13 sion works, headgates and measuring devices in their respective ditches, and
14 the cost of supervision as herein provided shall be borne by the parties
15 hereto, in the ratios that their respective maximum continuous flow allotments,
16 as provided in Schedule 4 hereof, bear to the total of such maximum continuous
17 flow allotments provided in said Schedule 4.

18 (15th) IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the term
19 "directly apply to beneficial use", as herein used shall be construed to
20 designate the direct conveyance and application of water diverted to bene-
21 ficial use without intermediate storage, except such regulatory storage as
22 may be practiced for the purpose of equalizing the flow of water diverted to
23 a convenient irrigation head.

24 (16th) IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the term
25 "natural flow", as herein used, shall be construed to designate such flow as
26 will naturally occur at any given point in a stream from the run-off of the
27 watershed which it drains, from springs which naturally contribute to the
28 stream, from seepage, and from waste and return flow from dams, conduits and
29 irrigated lands; as distinguished from released stored water and from "foreign
30 water" directly conveyed to the stream from another watershed.

31 (17th) IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the term

1 "net available water supply of Clover Creek and its tributaries", as herein
2 used, shall be construed to designate the total amount of water available for
3 diversion by all of the various conduits diverting from Clover Creek and its
4 tributaries; i.e., the water crop of Clover Creek and its tributaries, plus
5 all waste and return flow of the stream system from dams, conduits and irri-
6 gated lands, less all channel losses in the stream system; said "net available
7 water supply of Clover Creek and its tributaries" at any given time to be
8 determined by combining the total of all quantities of water being diverted
9 from the stream system with the flow of Clover Creek immediately below all
10 diversions at the time.

11 (18th) IT IS FURTHER ORDERED, ADJUDGED AND DECREED that all allot-
12 ments of water hereinbefore made from Clover Creek and its tributaries, with
13 the exception of the power allotments of J. B. Anderson hereinbefore provided
14 in Paragraph (5th), shall be limited by usage during the season or irrigation,
15 which is hereby defined as the period commencing May first and extending to
16 October thirty-first, both dates inclusive, of each and every year; and that
17 nothing herein contained shall be construed as in any way limiting or re-
18 stricting the rights of the various parties hereto who require water from
19 Clover Creek and its tributaries outside of said season of irrigation, to
20 divert and use such of the waters of said stream system as they may be
21 legally entitled to, during the period between October thirty-first of each
22 year and May first of the succeeding year.

23 (19th) IT IS FURTHER ORDERED, ADJUDGED AND DECREED that all of the
24 allotments of water hereinbefore provided shall be diverted from the Clover
25 Creek stream system at the present points of diversion of the respective
26 ditches, as said points of diversion are described in Schedule 3 hereof;
27 and that the points of measurement of all of said allotments shall be at the
28 respective points of diversion from said Clover Creek and its tributaries.

29 (20th) IT IS FURTHER ORDERED, ADJUDGED AND DECREED that each and
30 every party to this action, his or her agent, successors, grantees and assigns
31 be and they are hereby perpetually enjoined and restrained from doing anything

1 in violation of the terms and provisions of this decree, or diverting any
 2 water from said Clover Creek and its tributaries at any time in violation
 3 of the terms hereof, or from doing anything that will obstruct or interfere
 4 with any other right in this decree adjudged and decreed.

5 (21st) FINALLY IT IS ORDERED, ADJUDGED AND DECREED that each
 6 party hereto shall pay his own costs and that the amount due from the parties
 7 hereto so said Division of Water Resources for expenses incurred as referee,
 8 as set forth in the report of referee on file in this action shall be borne
 9 by the following parties in the following proportion:
