Judgment and Decree

28 The above entitled cause having been referred to the Division of  
29 Water Resources of the Department of Public Works of the State of California,  
30 as referee, by an order of this Court, dated September 26, 1932, and made  
31 under authority of law as conferred by Section 24 of the Water Commission  
32 Act of the State of California, Statutes of 1913, Chapter 586, as amended;

*winter decree*

1 said order of reference directing an investigation by said referee of all the  
2 facts and issues involved in said action and requiring said referee to report  
3 on all of the physical facts and such information upon the law and the facts  
4 as it might deem proper in view of the issues submitted and to recommend  
5 such findings of fact and conclusions of law as it might deem proper in view  
6 of the evidence; said referee having made its investigation; thereafter all  
7 of the parties plaintiff and defendants W. E. Dunwoody, Perry Opdyke,  
8 Charles Heryford and Fred Conrad, having entered into a written stipulation  
9 and agreement; said stipulation providing that this Court might enter its  
10 decree in accordance with the provisions of said stipulation; said stipulation  
11 further providing that findings of fact and conclusions of law be waived; said  
12 Division, as referee, having announced its report in the form of a draft;  
13 notice of said draft and a copy thereof having been mailed by said referee to  
14 the parties or their attorneys; defendants L. H. Sullivan and Eva B. Sullivan,  
15 and Mary H. Shearin having filed objections to said draft of report and the  
16 time for filing objections thereto having thereafter expired; due consideration  
17 having been given by said referee to said objections so filed; said referee  
18 having filed its report herein, including said stipulation for judgment as  
19 Exhibit "A"; said referee having given notice by mail of the filing of its  
20 report to the parties or their attorneys; defendants L. H. Sullivan and Eva B.  
21 Sullivan, and Gladys Gertrude Smith and Ermyl <sup>R</sup>oberta Ward and Ida May Wilcox,  
22 and Estate of Harry M. Wilcox, and A. L. Doty and Iva Doty, and Carrie Klotz  
23 Hall and W. P. Hall, and Harvey W. Wilcox, Vint W. Stevenson, Charles W. Gray  
24 and Ruby F. Hencrat having filed exceptions to said report of referee and the  
25 time for filing exceptions thereto having thereafter expired; the above entit-  
26 led cause having been set for hearing before this Court on December 18th, 1934,  
27 said hearing having been duly and regularly continued to the 19th day of  
28 February, 1935, and said cause having come on regularly for trial before the  
29 <sup>above</sup> entitled Court, sitting without a jury, on said 19th day of February, 1935;  
30 W. D. Tillotson, Esquire, appearing as counsel for plaintiffs; Jesse W. Carter,  
31 Esquire appearing as counsel for defendants Gladys Gertrude Smith, Ermyl

1 Roberta Ward, Ida May Wilcox, Estate of Harry M. Wilcox, A. L. Doty and Iva  
2 Doty, Vint W. Stevenson, Charles W. Gray, and Ruby F. Hencrat; Carr and  
3 Kennedy, Esquires, appearing for defendants W. E. Dunwoody and Mrs. M. H.  
4 Shearin, Carrie Klotz Hall, W. P. Hall and Harvey W. Wilcox; L. C. Smith,  
5 Esquire appearing for defendant Perry Opdyko; no appearances being made by or  
6 on behalf of any of the remaining defendants; said counsel for said parties  
7 having stipulated in open court that a decree be entered in accordance with  
8 said stipulation for judgment as amended by the changes therein proposed and  
9 recommended in said report of referee; said stipulation for entry of decree  
10 having been spread upon the minutes of the Court and findings of fact and  
11 conclusions of law having been thereby waived; defendants Alex Brown, Dessie  
12 Snooks, Holiday Brown, Edith Snooks, Jackson Bone, Lee Bone, Sam Williams,  
13 Julia Wilson, Harry Bob, Clara Grant, Lorena Wilson Mitchell, Alta Wilson  
14 Mullen, Hattie Wilson, Flora Wilson, Ira Wilson and Kate Snooks having  
15 been duly served with summons and complaint in said cause and having failed  
16 to plead or appear in said cause within the time limited by law and the  
17 default of said defendants having been duly and regularly entered by the  
18 clerk of this Court; defendants L. H. Sullivan and Eva B. Sullivan, and  
19 William Valentine and Fred Valentine having been duly and regularly notified  
20 of the hearing and trial of said cause before this Court, and said  
21 defendants having failed to appear at said hearing and trial, and having  
22 thereby waived findings of fact and conclusions of law; the evidence  
23 presented and filed by the referee and included within its report being  
24 the only evidence offered or introduced at said trial; the evidence being  
25 closed; said cause being submitted to the Court for its determination and de-  
26 cision; the Court being fully advised in the premises; and it further  
27 appearing as follows:

28           (1) Plaintiff Alan Brown has succeeded to the interests of  
29 plaintiff Ellen Brown involved in this cause.

30           (2) Sofia Lonquist, Mrs. Sofia Lonquist, and Sophia U. Lonquist  
31 are one and the same person.

1           (3) A. L. Doty and Asa L. Doty are one and the same person.

2           (4) W. E. Dunwoody has succeeded to the interests of defendants  
3 Inigo Jones and Elsie Jones involved in this cause.

4           (5) Charles Heryford and C. R. Heryford are one and the same  
5 person.

6           (6) Defendant Perry Opdyke has succeeded to the interests of  
7 defendant Olive Opdyke involved in this cause.

8           (7) Mrs. M. H. Shearin and Mary H. Shearin are one and the  
9 same person.

10          (8) Defendants Iva Doty and A. L. Doty have succeeded to the  
11 interests of defendant H. Morris involved in this cause.

12          (9) Defendants Felice Kelly Davis, Theodore A. Kelley, and the  
13 Red River Lumber Company have no interest in any water rights from Hat  
14 Creek and the said parties should be dismissed as defendants in this  
15 cause.

16          (10) S. E. Kerns has succeeded to the interests of Fred Conrad  
17 who signed said stipulation for judgment as successor to the interests  
18 of defendants Clare Brown and Fay Brown involved in this cause.

19          (11) The true name of defendant herein sued as Charles Sidney  
20 Gray is Charles W. Gray and he has appeared in said action under his true  
21 name.

22          (12) Kate Snooks, Greely Snooks, Cecilia Barnes, and Dessie  
23 Snooks, all of whom are Indians, have succeeded to the interests of  
24 defendant Charley Snook involved in this cause.

25          (13) Lorena Wilson Mitchell, Alta Wilson Mullen, Hattie Wilson,  
26 Flora Wilson, and Ira Wilson, all of whom are Indians, have succeeded to  
27 the interests of defendant Roy Wilson involved in this cause.

28          (14) Defendants Edith Snooks, Sam Williams, Lee Bone, Alex Brown,  
29 Julia Wilson, Harry Bob, Clara Grant, Dessie Snooks, Holiday Brown, and  
30 Jackson Bone are Indians.

31

1           NOW THEREFORE IT IS HEREBY ORDERED, ADJUDGED AND DECREED AS  
2 FOLLOWS, TO WIT:

3           (1st) There is in said Shasta County a natural stream of  
4 water known as and called "Hat Creek", which said stream arises on the  
5 northeast slope of Mt. Lassen in the southeasterly portion of Shasta  
6 County, State of California, and flows in a general northerly direction  
7 to its confluence with Rising River near Cassel between well defined  
8 banks in a well defined channel to, upon, and across certain of the lands  
9 of certain of the parties to this action, which lands are hereinafter  
10 described.

11           (2nd) The parties plaintiff and parties defendant in the above  
12 entitled action are the owners of the lands described in their respective  
13 pleadings, and as amended and pleaded by them; the allotments of water  
14 from said Hat Creek as hereinafter set forth are for use upon the acreages  
15 hereinafter described; the respective parties are the owners of the  
16 acreages hereinafter set forth under their respective names and of all  
17 the lands embraced in the legal sub-divisions hereinafter described under  
18 their respective names; and said lands are depicted on the map herein  
19 referred to as the "Division of Water Resources Maps", which maps were  
20 prepared by the State Water Commission from its surveys made in 1920 of  
21 the lands irrigated from Hat Creek, which maps are on file in the office  
22 of the Clerk of the above entitled Court as Plaintiffs' Exhibit No. 1 in the  
23 case of David Doyel, et al. v. Harvey Massie, et al., and the maps prepared  
24 by the Division of Water Rights from its surveys made in 1927 of reclaimed  
25 mud flow lands irrigated from Hat Creek, which maps are a public record on  
26 file in the office of said Division of Water Resources.

27           (3rd) The parties plaintiff and the parties defendant are the  
28 owners of, or interested in, the ditches, conduits, pipe lines and other  
29 means of diversion described in their respective pleadings, and as  
30 amended and pleaded by them, and as depicted on said Division of Water  
31

1 Resources maps and are entitled to divert water, as hereinafter set  
2 forth, through said means of diversion at the points of diversion  
3 depicted on said maps, and as hereinafter described.

4 (4th) The several parties named in Schedule 2, hereunto  
5 annexed and made a part hereof, are entitled to rights in and to the  
6 natural flow of Hat Creek, during the period commencing at 6:00 o'clock  
7 A.M. on October 28th of each and every year and ending at 6:00 A.M.  
8 on May 1st of the succeeding year, for domestic, stock watering and  
9 irrigation purposes upon their respective lands as described in  
10 Schedule 1, hereunto annexed and made a part hereof, in accordance  
11 with the quantities of water allotted and through the ditches named  
12 as set forth in said Schedule 2; said allotments are equal in priority  
13 and correlative in right and shall be limited to the amounts directly  
14 applied to beneficial use, and at all times when the available water  
15 supply of said creek is inadequate to fully supply said rights and  
16 allotments, then during the continuance of such shortage, the owners  
17 of said allotments shall prorate the available water supply in accordance  
18 with their respective allotments.

19 (5th) Defendants Mrs. M. H. Shearin, W. E. Dunwoody, and  
20 Clara Grant are entitled to divert from the natural flow of Hat Creek,  
21 during the period commencing at 6:00 o'clock A. M. on May 1st and  
22 terminating at 6:00 o'clock A. M. on October 28th of each and every  
23 year, in the respective amounts of water set after their respective  
24 names and through their respective ditches set opposite their respective  
25 names, to-wit:

30 Said rights provided in this paragraph are for use for irrigation, stock  
31 watering and domestic purposes by the parties named in this paragraph

1 upon their respective lands described in Schedule 1 hereof during the  
2 irrigation season defined in this paragraph and are equal in priority and  
3 correlative in right with all irrigation rights provided in the decree of  
4 the above entitled Court in Case No. 5724, entitled "David Doyel, et al.  
5 vs. Harvey Massie, et al.", and at all times when the available water  
6 supply of said creek is inadequate to supply all prior minimum flow rights  
7 provided in said decree and to fully supply said decree irrigation rights  
8 and the rights provided in this paragraph, then during the continuance of  
9 such shortage, the owners of said decreed irrigation rights and the rights  
10 provided in this paragraph shall prorate the water supply available over  
11 and above said prior minimum flow rights in accordance with their respective  
12 allotments.

13 (6th) Mrs. M. H. Shearin, W. E. Dunwoody, and Clara Grant, or  
14 any two of them, may elect to rotate in the use of their allotments  
15 hereinbefore provided in paragraph (5th); provided, however, that if rotation  
16 is practiced by said defendants, or any two of them, they shall rotate in  
17 the use of water with each other in such a manner that the consumption of  
18 water by them will equally reduce the amounts of water available for the  
19 rights of both the Lower Users and the Upper Users as adjudged and decreed  
20 in said decree of the above entitled court in the case of David Doyel, et  
21 al., vs. Harvey Massie, et al.; and provided further that each of said  
22 parties, during such times as they are not entitled to an irrigation head  
23 under such rotation, shall be entitled to a minimum flow of 0.25 cubic foot  
24 per second, which minimum flows shall be equal in priority and correlative  
25 in right with all minimum flows entitled to be diverted at that time under  
26 the decree in said case of "David Doyel, et al., vs. Harvey Massie, et al."

27 (7th) Mrs. M. H. Shearin, W. E. Dunwoody, and Clara Grant, each  
28 have the right to divert sufficient water to develop power on their  
29 respective lands herein described during the period commencing at 6:00  
30 o'clock A.M. on May 1st and terminating at 6:00 o'clock A.M. on October  
31 28th of each and every year, provided that their use for this purpose does

1 not deprive any of the other users of the quantity of water allotted to them  
2 in said decree of David Doyel, et al., vs. Harvey Massie, et al. for  
3 domestic, stock watering and irrigation purposes, the water to be directly  
4 returned to the creek from the place of use.

5 (8th) In addition to the amount of water hereinbefore allotted  
6 to Carrie Klotz Hall and W. P. Hall, through the Hall Ditch, for domestic,  
7 stock watering and irrigation purposes, said Carrie Klotz Hall and W. P.  
8 Hall are at all times entitled to divert from the waters of Hat Creek  
9 through said Hall Ditch, ten cubic feet per second, to be used for the  
10 purpose of operating a power wheel situated in the NW<sup>1</sup>/<sub>4</sub>SW<sup>1</sup>/<sub>4</sub> Section 33,  
11 T 33 N, R 5 E, M.D.B. & M.; provided that all of said water other than that  
12 necessarily lost by evaporation and seepage, shall be directly returned to  
13 said Hat Creek from said place of use; except that a quantity of water not  
14 exceeding 0.50 cubic foot per second out of said ten cubic feet per second  
15 may be used for the purpose of conveying sawdust and refuse from the sawmill  
16 situated on the above described forty acre tract, and need not be returned  
17 to said Hat Creek.

18 (9th) Harvey W. Wilcox, Vint W. Stevenson, Ruby F. Hencrat and  
19 Charles W. Gray, collectively, are at all times entitled to divert from  
20 the natural flow of Hat Creek, through Old Channel, ten cubic feet per  
21 second, said water to be diverted from said Hat Creek at a point within  
22 Lot 2 of Section 7, T 32 N, R 5 E, M.D.B. & M., and said parties are entitled  
23 to re-divert from such waters so diverted, in whole or in part, their  
24 respective allotments or prorrations thereof under their respective rights  
25 hereinbefore provided in paragraph (4th) in lieu of diverting an equal  
26 amount directly from said Hat Creek as provided in said paragraph (4th);  
27 provided, however, that any water flowing in said Old Channel not so re-  
28 diverted shall be returned to said Hat Creek in the SW<sup>1</sup>/<sub>4</sub>SE<sup>1</sup>/<sub>4</sub> Section 32,  
29 T 33 N, R 5 E, M.D.B. & M.

30 (10th) William Valentine, Fred Valentine, Charles Heryford, and  
31 Edith Snooks, collectively, are at all times entitled to divert from the



1 natural flow of Hat Creek, through Hahn Channel, eight cubic feet per second,  
2 said water to be diverted from said Hat Creek at a point within the NW<sup>1</sup> SE<sup>1</sup>  
3 Section 35, T 34 N, R 4 E, M.D.B. & M., and they are entitled to re-divert  
4 from such waters so diverted, in whole or in part, their respective allot-  
5 ments or prorations thereof under their respective rights hereinbefore  
6 provided in paragraph (4th) in lieu of diverting an equal amount directly  
7 from said Hat Creek as provided in said paragraph (4th); provided, however, *winter*  
8 that any water flowing in said Hahn Channel not so re-diverted shall be  
9 returned to said Hat Creek in the NE<sup>1</sup> NE<sup>1</sup> Section 27, T 34 N, R 4 E, M.D.B. & M.

10 (11th) Each and every party to this action, except Vernon March,  
11 and S. E. Kerns, have the right to divert sufficient water from Hat Creek  
12 to develop power on their respective lands herein described, provided that  
13 their use for this purpose does not deprive any of the other users of the  
14 quantity of water allotted to them for domestic, stock watering and irrigation  
15 purposes, the water to be directly returned to said creek from the place of  
16 use.

17 (12th) All allotments of water provided in this judgment and  
18 decree, except the allotments hereinbefore provided in paragraphs (5th),  
19 (6th) and (7th) for Mrs. M. H. Shearin, W. E. Dunwoody and Clara Grant,  
20 shall be limited to usage during the season commencing at 6:00 o'clock A.M. *winter*  
21 on October 28th of each and every year and ending at 6:00 o'clock A.M. on  
22 May 1st of the succeeding year; said allotments hereinbefore provided in  
23 paragraphs (5th), (6th) and (7th) for Mrs. M. H. Shearin, W. E. Dunwoody  
24 and Clara Grant shall be limited to usage during the season commencing at  
25 6:00 o'clock A.M. on May 1st and terminating at 6:00 o'clock A.M. on  
26 October 28th of each and every year; and nothing in this judgment and decree  
27 shall, or shall be construed to, modify or alter in any way the relative  
28 rights of those parties to this action whose rights were decreed by the above  
29 entitled court in case No. 5724 entitled "David Poyel, et al., vs. Harvey  
30 Massie, et al.," with respect to each other during the season commencing at  
31 6:00 o'clock A.M. on May 1st and ending at 6:00 o'clock A. M. on October  
28th of each and every year.

1           (13th) All of the allotments of water hereinbefore provided  
2 shall be diverted from the Hat Creek stream system at the present points of  
3 diversion of the respective ditches, as said points of diversion are described  
4 in Schedule 3, hereunto annexed and made a part hereof; and the points of  
5 measurement of all of said allotments shall be at the respective points of  
6 diversion from said Hat Creek stream system, except that in the case of the  
7 Reiger Ditch owned jointly by Harry A. Lonquist, S. E. Kerns, L. H. Sullivan  
8 and Eva B. Sullivan, the allotment of water herein allowed L. H. Sullivan  
9 and Eva B. Sullivan shall be measured at the northern boundary of the Clare  
10 and Fay Brown Ranch, and the allotment of water herein allowed S. E. Kerns  
11 shall be measured immediately above the point where the upper lateral lead-  
12 ing to the Clare and Fay Brown Ranch diverts water from said Reiger Ditch;  
13 provided, however, that the allowance for transportation losses in said  
14 Reiger Ditch for said L. H. Sullivan and Eva B. Sullivan, and S. E. Kerns  
15 shall at no time exceed 1.75 cubic feet per second.

16           (14th) Nothing herein contained shall, or shall be construed to,  
17 limit or restrict the right of any two or more parties hereto from entering  
18 into an agreement or agreements, whereby said parties may pool their  
19 respective interests and thereby apply water to their respective lands at a  
20 greater rate than herein provided, provided that the total use of any such  
21 parties on their lands during any 30 day period shall not exceed the allot-  
22 ments herein provided, and provided further that such use shall not impair  
23 or infringe the right of any other party; and nothing herein contained  
24 shall, or shall be construed to, preclude Mrs. M. H. Shearin from consummat-  
25 ing a right to appropriate unappropriated waters of Hat Creek under an  
26 application and permit pending before said Division of Water Resources.

27           (15th) IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the  
28 term "natural flow", as herein used, shall be construed to designate such  
29 flow as will naturally occur at any given point in a stream from the runoff of  
30 the watershed which it drains, from springs which naturally contribute to  
31 the stream, from seepage, and from waste and return flow from dams,

1 conduits and irrigated lands; as distinguished from released stored water  
2 and from "foreign water" directly conveyed to a stream from another water-  
3 shed.

4 (16th) IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the term  
5 "available water supply of Hat Creek", as herein used, shall be construed  
6 to designate the total amount of water available for diversion by all of the  
7 various conduits diverting from Hat Creek, i. e. the water crop of Hat Creek  
8 plus all waste and return flows to the stream system, less all channel losses  
9 in the stream system; said "available water supply of Hat Creek" at any given  
10 time to be determined by combining the total of all quantities of water being  
11 diverted from the stream system with the flow of <sup>H</sup>at Creek immediately below  
12 all diversions at such given time.

13 (17th) IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the court  
14 retains jurisdiction to enforce the provisions of this decree by the appoint-  
15 ment of the Division of Water Resources of the Department of Public Works  
16 of the State of California, as water master, and to appoint any other  
17 qualified agency or any person to so act at such times as may be necessary  
18 in the event that said Division, or its successor, if any, in the administrat-  
19 ion of the Water Commission Act, fails to act as such water master under  
20 said appointment or under provisions of law authorizing water master super-  
21 vision over the distribution of the waters herein decreed, and that all costs  
22 and expenses of such water master service shall be borne by the parties hereto,  
23 Indians occupying government land excepted, said costs and expenses to be  
24 apportioned among said parties in accordance with the methods of apportion-  
25 ing the costs of water distribution by water master provided in Section 37f  
26 of said Water Commission Act.

27 (18th) IT IS FURTHER ORDERED, ADJUDGED AND DECREED that each and  
28 every party to this action, his or her agents, successors, grantees and  
29 assigns, be and they are hereby perpetually enjoined and restrained from  
30 doing anything in violation of the terms or provisions of this decree, or  
31 diverting any water from said Hat Creek at any time in violation of the

1 terms hereof, or from doing anything that will obstruct or interfere  
2 with any other right in this decree adjudged and decreed.

3 (19th) IT IS FURTHER ORDERED, ADJUDGED AND DECREED that action  
4 against Felice Kelly Davis, Theodore A. Kelley, and The Red River Lumber  
5 Company be dismissed.

6 (20th) FINALLY IT IS ORDERED, ADJUDGED AND DECREED that each  
7 party hereto shall pay his own costs and that the amount due from the  
8 parties hereto to said Division of Water Resources for expenses in-  
9 curred as referee, as set forth in the report of referee on file in this  
10 action shall be borne by the following parties in the following proportion:

At a point which bears approximately N 15°30' E, approximately 2970 feet distant from the Southwest corner of Section 29, T 35 N, R 4 E, M.D.B. & M., and being within the SW $\frac{1}{4}$  NW $\frac{1}{4}$  of said Section 29.

Doyel East Ditch

At a point which bears approximately N 86°00' E, approximately 1550 feet distant from the Southwest corner of Section 20, T 35 N, R 4 E, M.D.B. & M., and being within the SE $\frac{1}{4}$  SW $\frac{1}{4}$  of said Section 20.

Doyel Ditch

At a point which bears approximately N 85°00' E, approximately 1525 feet distant from the Southwest corner of Section 20, T 35 N, R 4 E, M.D.B. & M., and being within the SE $\frac{1}{4}$  SW $\frac{1}{4}$  of said Section 20.

Bertha Giessner Ditch

At a point which bears approximately N 40°00' E, approximately 2045 feet distant from the Southwest corner of Section 20, T 35 N, R 4 E, M.D.B. & M., and being within the NE $\frac{1}{4}$  SW $\frac{1}{4}$  of said Section 20.

Otto Giessner Ditch

At a point which bears approximately N 13°30' W, approximately 1880 feet distant from the Southeast corner of Section 18, T 35 N, R 4 E, M.D.B. & M., and being within the NE $\frac{1}{4}$  SE $\frac{1}{4}$  of said Section 18.
